Benton County Finance Committee Minutes May 30, 2023

Ken Spencer called the Benton County Finance meeting to order on May 30, 2023, at 11:03 a.m.

Present Treasurer Ken Spencer, Auditor Brenda Chilton (remote), and Commissioner Will McKay (remote). Also present were county staff members, Heather Hutchison, Jeanette Ulick, Kirsten Yniguez of the Treasurer's Office, and Lorene Roe (remote) of the Auditor's Office

Approval of the Minutes

Brenda moved to approve the 2022 4th quarter minutes. Will seconded and minutes were approved.

Heather presented the 1st Quarter, 2023, Analysis:

The 1st quarter ending 03/31/2023 had a portfolio balance of \$402,363,744.40.

1st quarter portfolio activity for the Treasurer's Investment Pool (TIP) included purchases of \$24,611,884.96 and maturities of (\$17.812,568.75).

2nd Quarter Strategy

- Continue with bi-weekly FHN Financial conference calls and internal discussions.
- Invest in securities according to the policy; being aware of the current market conditions.
 - Primary focus is to ensure cash flow needs can be met while filling the upcoming year's monthly buckets with new investment purchases.
- Discuss the market conditions for upcoming maturities with FHN for reinvesting.
- Set up in-person visits for schools and districts to discuss rate increases and updated cash flow needs as staff has retired or taken other positions.

Discussion

Ken stated the County is providing better cash needs so informed investing decisions can be made. School districts need to be made aware of their cash needs, the County is offering short term cash loans with interest.

Approval of Minutes

Interest rates are still high. The County recently invested \$10,000,000 in bonds which will return at a better rate then what has been available recently.

Brenda stated the juggling investment but still having cash on hand has been well managed by the Treasurer's Department.

Brenda moved to adjourn, Will seconded.












